The product is a water-based equalising primer REVITALPRIMER (JUBOSIL EX), JEX.

· Product category

REVITALPRIMER (JUBOSIL EX) is a primer used before dispersion products are applied – it is based on potash water glass.

· Application of the substance / the mixture

REVITALPRIMER is a primer filled with synthetic micro-fibres and fine quartz sand. It is based on potash water glass and acrylic binders. It is used to cover hairline-cracked - fine levelled or rustically processed - surfaces and unevenly coarse - mended surfaces before they are painted with micro-reinforced and other paints, and it can also be used as a primer when applying various more demanding decorative techniques of interior wall surface processing.

It fills cracks well, equalises the surfaces with regard to roughness and water absorption, and it binds dust and other badly-adhered particles which could not have been removed with cleaning for whatever reason.

Main ingredients of REVITALPRIMER are polymeric binders based on styrene-acrylate emulsion, potash water glass, silicate fillers, titanium dioxide, cellulose thickening agent, supplements and water.
