· Product category

Products AKRILNI ZARIBAN OMET / ACRYLIC TROWELLED RENDER 1.0, 1.5, 2.0 and 2.5 are dispersed thin layer plasters, manufactured on the basis of acrylic polymeric binders with characteristic evenly grained surface and are intended for decorative protection of facade wall surfaces.

· Application of the substance / the preparation

In addition to high strength the products AKRILNI ZARIBAN OMET are distinguished by high water-resistance. Acrylic plasters are distinguished also due to atypical, relatively high values of vapour permeability and may be installed as final and decorative plasters in the contact facade thermal-insulation systems.

Acrylic plasters are easily applied and a large number of pastel shades are available in the tinting system.

Use of acrylic plasters provides long-term resistance of surfaces against contaminations with wall algae and mould; therefore addition of biocidal substances prior to installation is not required.


