· Decorative self-cleansing siloxane acrylic smooth plaster for outer walls UNIXIL G, UXG ver. 2

· Product category

Products UNIXIL G 1.0, 1.5, 2.0 and 2.5 are thin layer noble plasters, manufactured on the basis of polymeric binders with characteristic evenly grained surface and are intended for decorative protection of facade wall surfaces. They easily grasp all finely grained construction foundations: basic plasters of facade thermal insulation systems, classical fine lime-cement and cement plasters, smooth concrete surfaces, as well as fibre-cement and drywall plates, chipboards, etc.

· Application of the substance / the preparation

In addition to high strength the products UNIXIL G are distinguished by the content of components, which provide high resistance to the effects of smoke gases, UV rays and other atmospheric conditions and is therefore stable under all climatic conditions, including facade surfaces heavily exposed to precipitation. Due to high content of silicone binders and siloxane additives the surfaces treated with UNIXIL G are poorly grasped by dust, soot and other dirt; these are largely washed from the exposed surfaces by the rain. Long-term resistance of surfaces against contaminations with wall algae and mould is provided; therefore addition of biocidal substances prior to installation is not required.

Silicone plasters are somewhat easy for application and a large number of pastel shades are available in the tinting system.


