JUBOGLET is a gypsum compound used for levelling larger wall or ceiling surfaces and uneven parts in coat thickness of up to 8 mm. It can also be used to fill joints between gypsum-cardboards, and to repair scratches in depth of up to 8 mm and abrasions and hollows on interior wall and ceiling surfaces. Repaired and levelled surfaces are white and can be painted with all types of dispersion wall paints if they are finely levelled beforehand with JUBOGLET, NIVELIN, JUBOLIN, JUBOLIN P25 or JUBOLIN P50.
