· **Application of the substance / the mixture**

JUBOLIN REPARATUR is used to repair smaller damages, indentations, cracks, holes, abrasions, chinks and similar flaws on interior wall and ceiling surfaces. After being processed, surfaces are of dirty white colour and suitable to be painted with all types of dispersion wall paints, wallpapered or treated in any other decorative manner.

It adheres well to lime, lime-cement and also cement fine renders and gypsum-cardboards. It can also be used to make repairs on unplastered concrete surfaces, fibre-cement boards, chipboards and similar. It can also be applied onto already painted surfaces, but only if the existing coats do not soak in water and are well adhered to the surface. It is distinguished by extremely high thixotropy.
