The product is water-based silicate translucent paint JUB DECOR ANTIQUE (JUBOSIL ANTIK), JSA .

**· Product category**

JUB DECOR ANTIQUE (JUBOSIL ANTIK) is a decorative facade and interior paint based on potash water glass.

**· Application of the substance / the mixture**

JUB DECOR ANTIQUE (JUBOSIL ANTIK) is a translucent wall paint based on potash water glass. It can be used for decorative protection of facade surfaces (suitable surfaces include fine and course mineral renders of all types, decorative silicate renders and well-adhered old silicate coats), especially on buildings of architectural heritage (buildings in old city centres, churches, castles and similar) and also on new buildings of all types – catering establishments, commercial and other business premises, old and new residential buildings and similar (suitable surfaces include fine and course mineral renders of all types, decorative silicate renders and well-adhered old silicate coats and, when using an adequate primer, it is also possible to apply the product onto surfaces levelled with modern levelling compounds and surfaces painted with dispersion wall paints) for decorative treatment of backcloths in theatre-, television- and film scene technique. The paint is distinguished by high translucence and a special application technique, both providing interesting and also archaic appearance to treated surfaces when suitable colour shades are selected. JUB DECOR ANTIQUE / JUBOSIL ANTIK binds chemically to the surface and is distinguished by high water vapour permeability. Paint film is resistant to the effects of smoke, ultraviolet radiation and other atmospheric factors; it is resistant in any climatic conditions.


The product is a chemical compound characterised by low content of hazardous substances.
