#### · General protective and hygienic measures:

Wash hands before breaks and at the end of work.

• **Respiratory protection:** Suitable respiratory protective device recommended.

#### · Protection of hands:

Due to missing tests no recommendation to the glove material can be given for the product/ the preparation/ the chemical mixture.

Protective gloves

Check protective gloves prior to each use for their proper condition.

The glove material has to be impermeable and resistant to the product/ the substance/ the preparation.
