The appearance of the relief surface depends on the application technique and a tool used for the structuring of the applied render. It adheres well to all fine-coarse construction surfaces including: classic fine lime-cement and cement renders, smoothed concrete surfaces and also fibre-cement and gypsum-cardboards, chipboards and similar. It is distinguished by high water vapour permeability and good adhesion to the surface.
